Self-proctored exam facilitated by mail or office drop-off. Completed practice test due 5 or more weeks before actual exam. Instruction typically includes one 2 hr "Lay the Foundation" session plus 3-5 additional sessions.

#### **Proctored exam option at Lane Tutoring Service office: add \$60**

Proctored practice tests are usually scheduled on a weekend 5 or more weeks before the actual exam.
